



#### WRITTEN PLAN

PROPOSED ACTIVITY: Herbicide spray operations within 100 feet of D or F type streams.

### PROTECTIVE MEASURES:

- 1. Spray operations shall be conducted in a manner to prevent any direct contact to D,N, or F type streams as identified on the enclosed map. A minimum 10' buffer on each side of the D or F creek will be required.
- 2. Temperature, humidity, and wind velocity requirements shall be strictly enforced (<5mph wind, <80degrees F, and >50% humidity with Garlon 4 applications, and < 5MPH wind Accord and Arsenal, or Garlon 3a foliar applications).
- 3. All chemicals are EPA approved, and shall be applied in accordance with labels.
- 4. All leave trees left along F, D or N type streams will not be sprayed.
- 5. Spray no Garlon 4 within 60' of a fish or domestic creek. Use Garlon 3a from 60' to within 10' of fish or domestic creek
