Attached is the processed information from the Notification of Operation/Application for Permit signed by Michael Tucker representing the Land Owner, and received by Department of Forestry on May 14, 2013. Please review this information and retain for future reference.

Notice is given to the State Forester that an operation will be conducted on the lands described herein.

A permit to use fire or operate power driven machinery is issued for the land described herein.

SF Comments: Written Plan received 5-14-13. Very few of the acres on the notification will be treated as the plants are well dispersed. Some of the Scotch Broom may be cut with no spraying taking place. Several herbicides are listed to allow for site specific prescriptions however it should be noted that only one herbicide is likely to be used at any single location. Maps depict primary spraying occurring near the road network however, other loci with the same legal description but farther away from road may be treated as well.

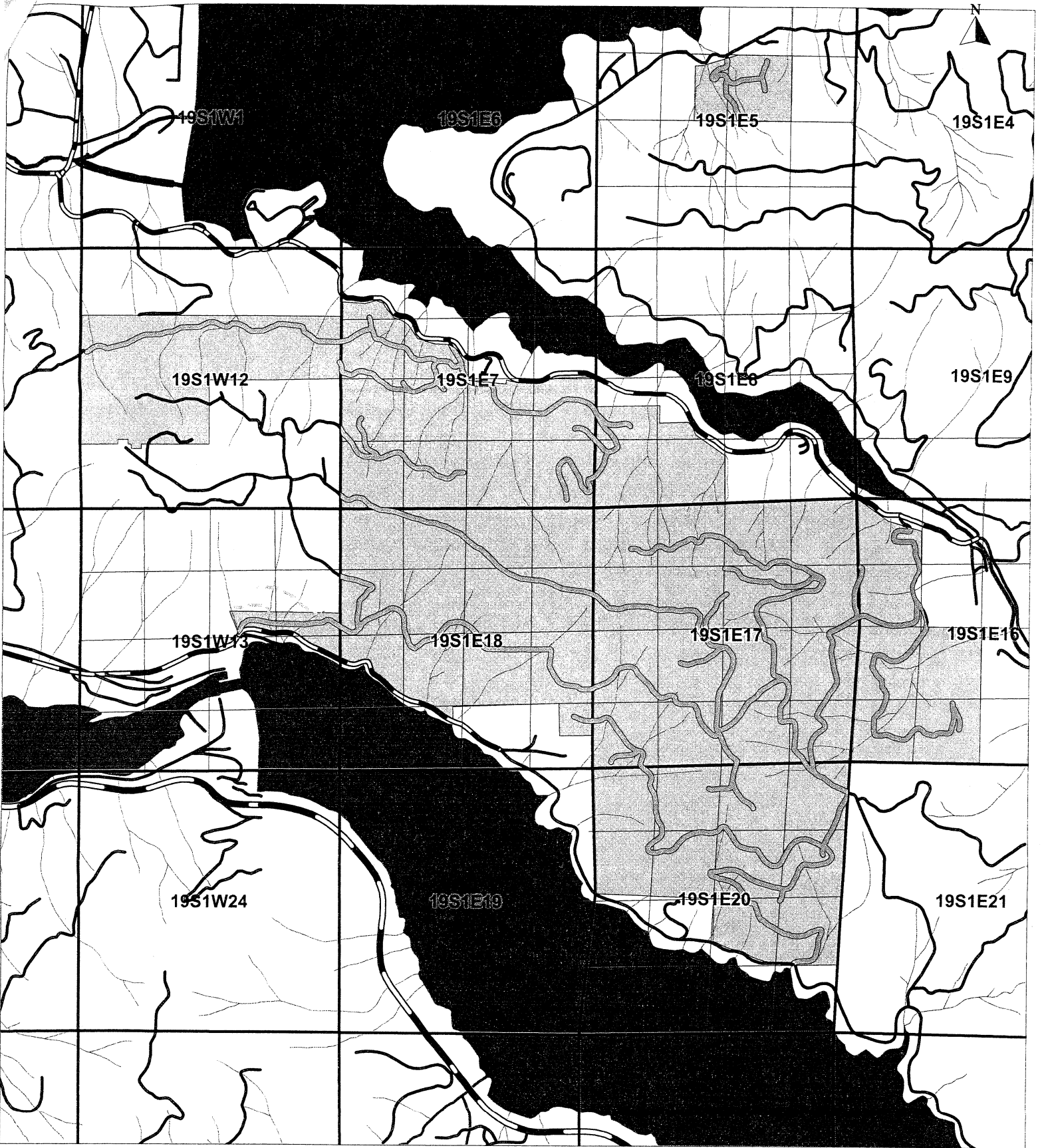
