Regarding the attached Statutory Written Plan for Clearcut/Overstory removal within 100 feet of the unnamed tributaries to Jordan Creek, a small unknown stream treated as a small fish: After reviewing your written plan, I offer you the following comments. Fully implementing this written plan is likely to achieve the resource protection standards. This operation will be evaluated on the basis of how well required practices are applied and how well required resource protection is achieved.

Land use conversion to non-forest use involves regulations administered by other state and local governments, which may apply to the future use or development of this site.

Call the Oregon Utility Notification Center at 811 at least 2 business days before starting timber harvesting, road construction, or any other activities involving excavation that may affect an underground utility line. The Center will coordinate with the appropriate utility companies to locate underground utility lines that may be affected by your activities.


