
STREAMS: Hills Creek, Little Fall Creek, Norton Creek, Sturdy Creek, Fall Creek,

Refer to the Weyerhaeuser map books on file at the Lane County ODF Office that show all fish
streams pertaining to this written plan.

No vegetation will be treated within 10 feet of Type F or Type D streams. The vegetation to be treated
is mostly scotch broom, alder, and blackberries that are encroaching the road running surface.
Spraying will be done with backpack sprayers and/or a truck-mounted spray system. No mixing will
take place within 100 feet of a Type F or Type D stream.
