



PROJECT DESCRIPTION: A ground herbicide application will be conducted to eradicate Broom Species that are spreading throughout the area. The Broom plants will be sprayed with 8% Glyphosate + 0.25% Herbimax mixed with water as the carrier and applied at a rate of 20 gal. / acre using backpack sprayers with flat fan nozzles.

Alternatively some areas with large established broom plants may be cut with machetes or chain saws.

PROTECTION MEASURES: All streams will be buffered by leaving a minimum of 10 feet of unsprayed and uncut vegetation. The crew will be briefed on the treatment of these areas through a combination of maps and an onsite discussion with the forester prior to treatment.
