- Within 300 feet of any resource identified in the Divisions 645 or 665 of the administrative rules. [OAR 629-605-170(1)(c)]

- Within 300 feet of a state or federally listed threatened or endangered wildlife resource site. [OAR 629-605-170(1)(d)]

Written Plan

UNIT: 2009 Spring Spray

LANDOWNER: Plum Creek

OPERATOR: Western Helicopter

PLANNED OPERATION: A spray operation is scheduled for the spring of 2009. The spray is designed to reduce the competing vegetation in the plantation in order to allow the trees to live and grow into a thriving productive stand. The project will be completed using a helicopter and ground crew. Plum Creek will provide a representative to review and explain all portions of this plan to the operator before they begin work.

TARGET VEGETATION: Grass, herbaceous and other competing plant species.

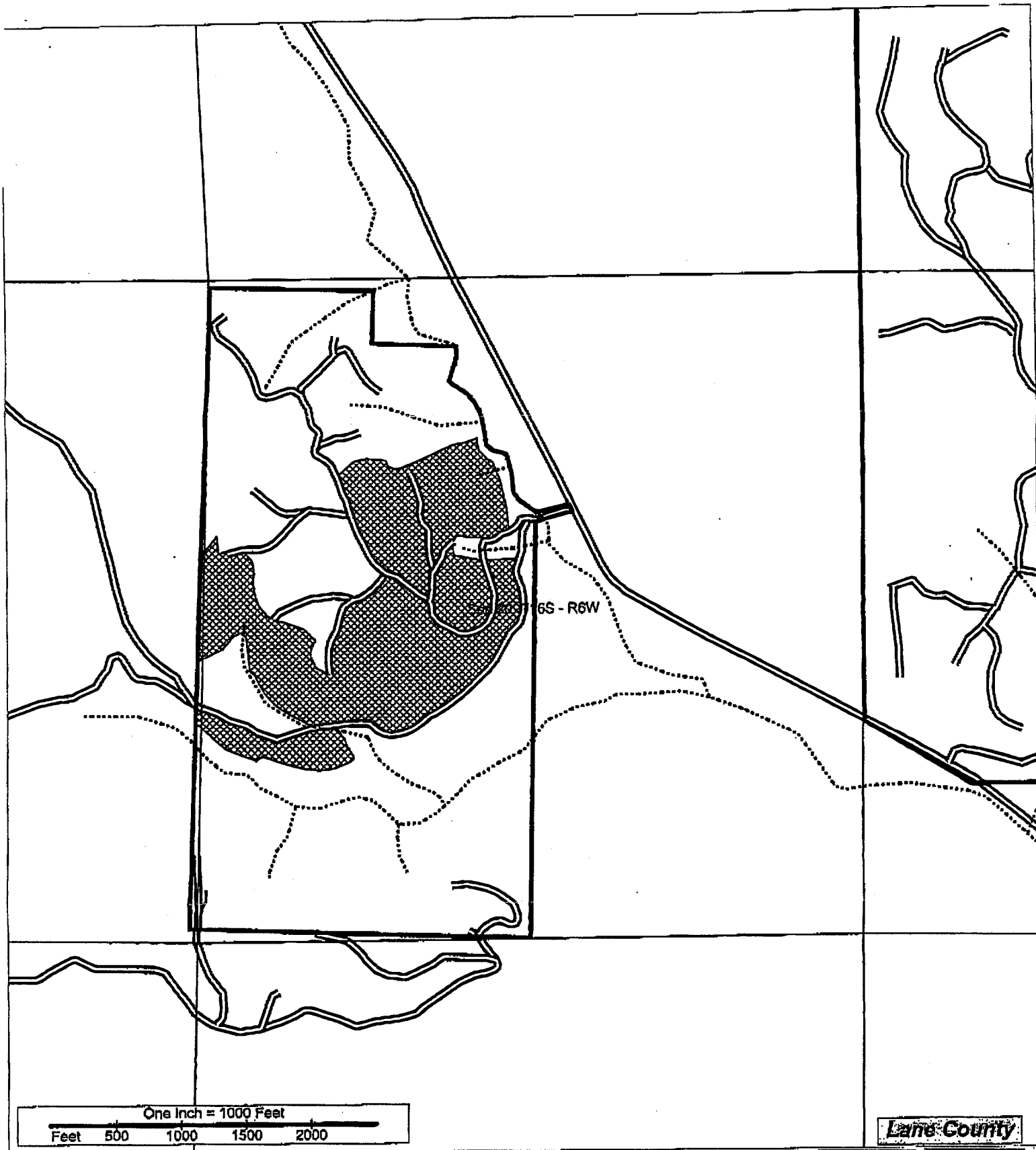
PROTECTED RESOURCES: See attached unit maps for protected streams and water systems.

PROTECTION MEASURES: The following measures will be taken to protect all Fish, Domestic, non-fish, Small, Medium and Large streams as well as significant wetlands:

1. Spray will not be directly applied to any small non-fish streams by helicopter or ground crew. At minimum a 60-foot buffer will be left unsprayed by the helicopter along Fish, Domestic, Medium and Large non-fish streams as well as significant wetlands unless cutting boundaries are farther than 60 feet then the spray boundary will be on the outside of the cutting boundary.
2. At a minimum a 10-foot buffer will be left unsprayed by ground crews along all Fish, Domestic, Medium and Large streams as well as significant wetlands unless cutting boundaries are farther than 60 feet then the spray boundary will be on the outside of the cutting boundary.
3. Spray will not be directly applied to any small non-fish streams by helicopter or ground crew.
4. Operations will not be performed if wind direction or velocity is such that protected resources are in danger of contamination
5. All operations will be performed in accordance with the Oregon Forest Practices Act as they relate to the use and handling of chemicals.
