Re: Written Plan for 2010 Roadside Spray Operations

Roseburg Resources Company herein submits a written plan for operations on our ownership for twelve Townships T17S 06W, T17S07W, T17S08W,T18S 06W, T18S07W, T18S08W, T19S05W, T19S07W,T19S08W, T20S05W, T20S06W in the West Lane Forest Protection District for roadside spray. The actual roads to be sprayed are marked on the attached 1" = 1 mile individual Township maps.

Reason for Plan: Operations within 100 feet of Type 'F' and 'D' streams.

Multiple type 'F' and 'D' streams occur across the ownership of Roseburg Resources Company. Roseburg Resources Company plans to apply herbicides within 100 feet of these type 'D' and 'F' streams along roadsides as indicated on maps. Roadside areas to be sprayed include the roadbed itself and the brush within 15 feet of the road bed on both sides. We will not directly apply herbicides within 10 feet of any stream.

All label directions will be followed during the application of chemicals. Roadside spray will be done with ground based equipment. All herbicide batching will be done at least 100 feet from any water source. Prior to and during the application period the applicator will monitor weather conditions to assess risk and continued plan success. These stream zone protection measures are consistent with best management practices and will not affect any of the required components of these riparian management zones.

In closing we believe these measures will benefit both the environment and the operations of Roseburg Resources Company. 




Roseburg Resources Timberlands: 18S 07W



Rosebuic Resources indicates treatment area






Roseburg Resources Timberlands: 19s 07w
