#### **PROTECTION OF STREAMS, LAKES, WETLANDS AND DWELLINGS WHEN APPLYING HERBICIDES.**

**UNITS:** A-6 (NAYA)

**SITE ACTIVITY:** HERBICIDE APPLICATION (GROUND)

**LOCATION:** WEBSTER

**TARGET SPECIES:** GRASS & FORBS

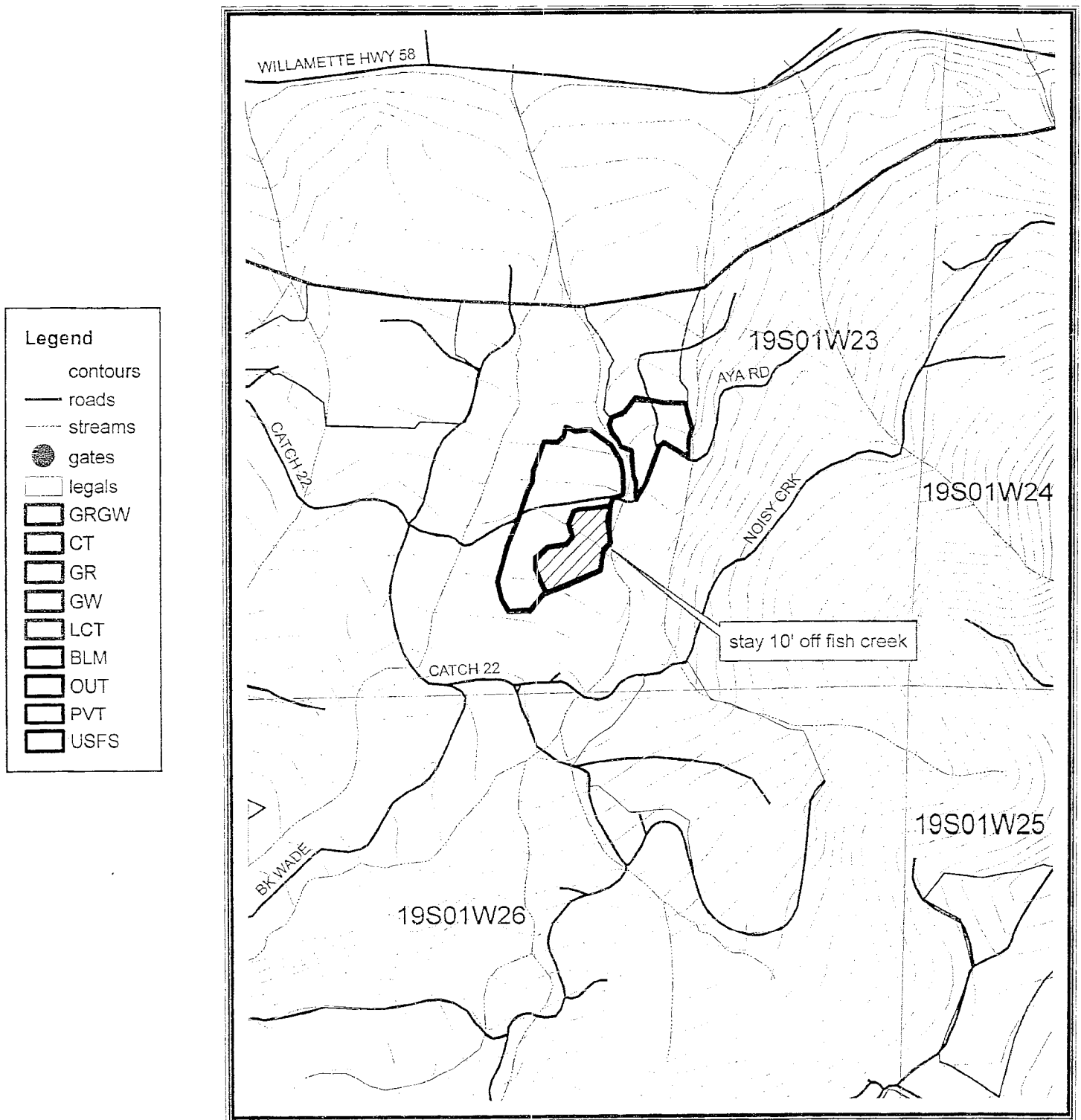
**PROPOSED ACTIVITY:** Herbicide spray operations within 100 feet of D or F type streams.

#### **PROTECTIVE MEASURES:**

1. Spray operations shall be conducted in a manner to prevent any direct contact to D,N, or F type streams as identified on the enclosed map. A minimum 10' buffer on each side of the D or F creek will be required.
2. Temperature, humidity, and wind velocity requirements shall be strictly enforced (<5mph wind, <80degrees F, and >50% humidity with Garlon 4 applications, and < 5MPH wind Accord, Velpar, Oust, Arsenal, or Garlon 3a plus Transline foliar applications).
3. All chemicals are EPA approved, and shall be applied in accordance with labels.
4. All required leave trees and vegetation in the RMA left along F, D or N type streams will not be sprayed.
