Unit 1 of 6 (He-Hate-Me):

A spotted owl site (Haney Creek Alt O) was identified within ½ mile of the proposed operation. However, this owl site has been determined to be a “resident single” resource site. Thus, it is not a protected resource site under the Forest Practices Act (OAR 629-600-0100(1)) and there are no Forest Practices Act restrictions. The Forest Practices act would provide protection should the site become occupied with a “nesting pair”. Please call if you have any questions (541)-935-2283.

Compliance with Forest Practices Rules does not guarantee compliance with the Federal Endangered Species Act. Parties conducting operations are subject to all Federal requirements as well as any requirements administered under the Forest Practice Rules. The Federal Endangered Species Act is enforced by U.S. Fish and Wildlife Service.

Notice to Landowner(s)

Reforestation may be required by the landowner if timber harvesting is part of the proposed operations.

On-site inspections may be conducted by Oregon Department of Forestry employees to ensure compliance with all laws and rules governing fire protection and forest practices on private land.

Land use conversion to non-forest use involves regulations administered by other state and local governments, which may apply to the future use or development of this site.

Notice to Operator(s)

If you are conducting timber harvesting or road construction within 100 feet of overhead utility lines contact the local utility in accordance with ORS 757.805 - Oregon's Overhead Safety Act and OAR 437-007-0230 - Power Line Safeguards. Identification tags are located on each pole.

Call the Oregon Utility Notification Center at 811 at least 2 business days before starting timber harvesting, road construction, or any other activities involving excavation that may affect an underground utility line. The Center will coordinate with the appropriate utility companies to locate underground utility lines that may be affected by your activities.

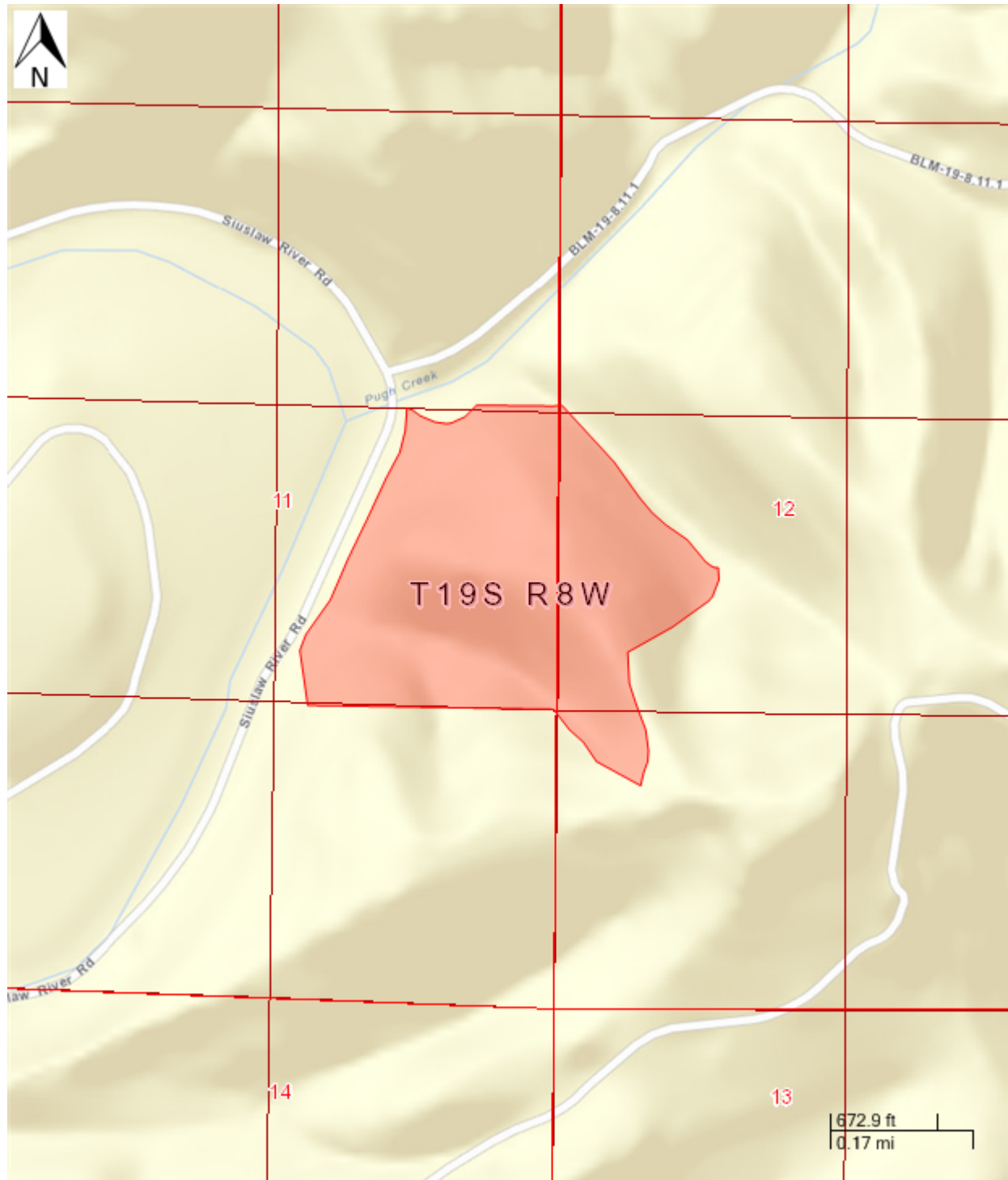

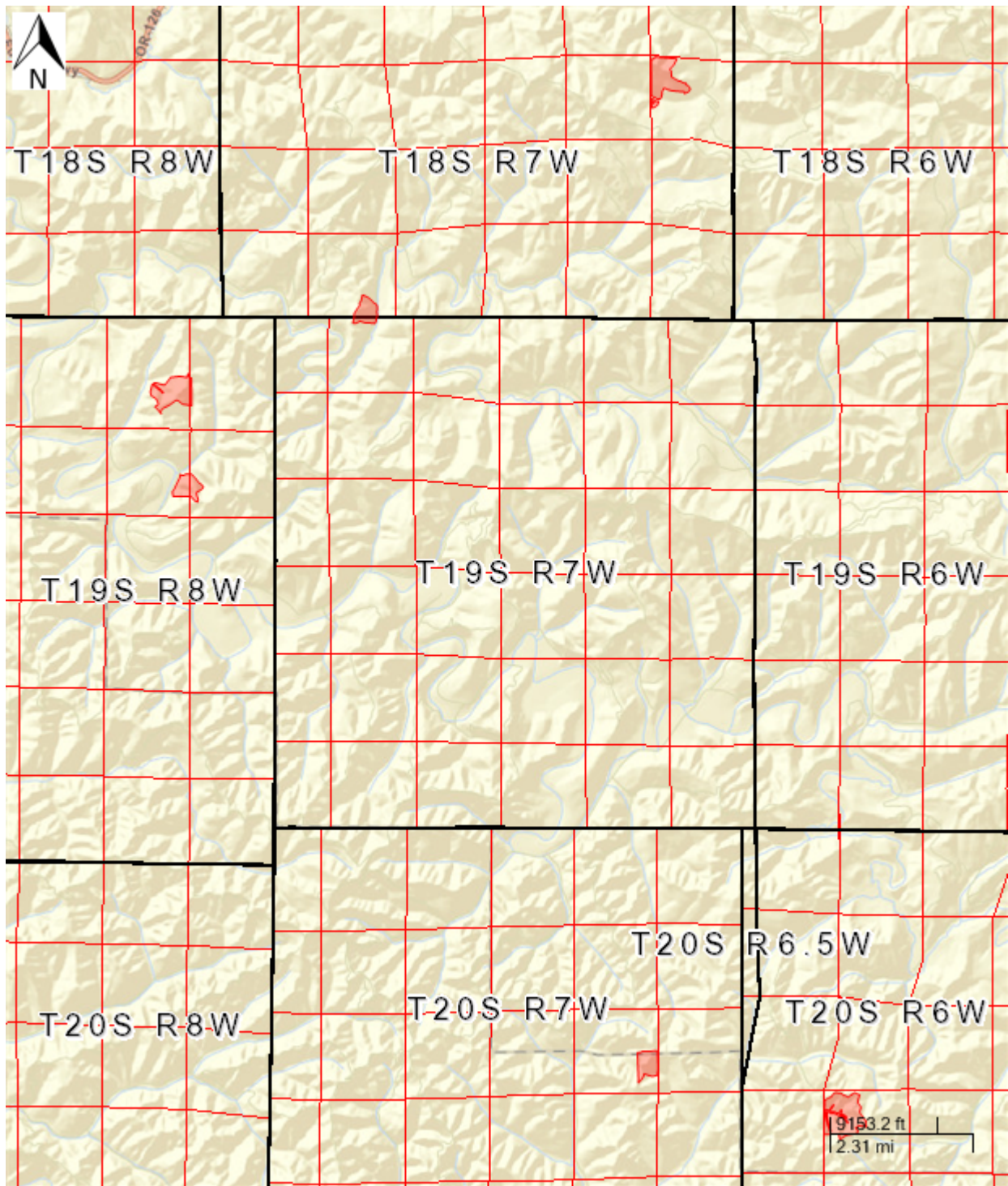
