Unit 3 of 10 (19-7-6)

The notified operation is located within ½ mile of critical wildlife habitat for the Northern Spotted Owl (Bill Lewis Ck Alt O Site). The proposed operation is less than ¼ mile from the nest site (970 ft), which is located on land managed by the Bureau of Land Management. The notified activity (aerial operation) would be considered a disturbance during the critical nesting period (March 1 to September 30) and is not allowed without a non-statutory written plan. The written plan must show how the conflict/disturbance will be resolved. The potential conflict may be resolved by either 1) For 2014 –evidence that the pair is not present, is not breeding, or has completed their breeding activities. 2) Avoid any aerial spraying which includes flyovers during the critical use period (March 1 to September 30). A written plan has not been turned in with the notification.

Unit 7 of 10 (9M)

A spotted owl site (North Sister Creek Alt O) was identified within ½ mile of the proposed operation. However, this owl site has been determined to be a "resident single" resource site. Thus, it is not a protected resource site under the Forest Practices Act (OAR 629-600-0100(1)) and there are no Forest Practices Act restrictions.

Please be aware that compliance with the Forest Practices Act is not in lieu of compliance with any federal requirements related to the federal Endangered Species Act. Federal law prohibits a person from taking northern spotted owls. Taking under the federal law may include significant alteration of owl habitat on any class of ownership (OAR 629-665-0210 (4)). Landowners and operators are encouraged to communicate directly with the USFWS regarding requirements under the federal Endangered Species Act.

This is regarding your Statutory Written Plan required by:
