# **Stewardship Forester Formal Comments**

Comment from: Dan Menk 11/18/2014

Unit 2 of 9 (Slideout Last)

A spotted owl site (Upper Johnson Creek Alt A) was identified within ½ mile of the proposed operation. However, this owl site has been determined to be a historic site and the protected site for the Johnson Creek Bird is the Alt O site. Thus, it is not a protected resource site under the Forest Practices Act (OAR 629-600-0100(1)) and there are no Forest Practices Act restrictions .The notified operation (aerial fertilizer) is greater than ½ mile from the protected site.

Please be aware that compliance with the Forest Practices Act is not in lieu of compliance with any federal requirements related to the federal Endangered Species Act. Federal law prohibits a person from taking northern spotted owls. Taking under the federal law may include significant alteration of owl habitat on any class of ownership (OAR 629-665-0210 (4)). Landowners and operators are encouraged to communicate directly with the USFWS regarding requirements under the federal Endangered Species Act.
