Regarding the attached Statutory Written Plan for Clearcut/Overstory removal within 100 feet of Health Creek, a small unknown stream treated as a small fish: After reviewing your written plan, I offer you the following comments. This operation will be evaluated on the basis of how well required practices are applied and how well required resource protection is achieved.

Reforestation may be required by the landowner if timber harvesting is part of the proposed operations.

On-site inspections may be conducted by Oregon Department of Forestry employees to ensure compliance with all laws and rules governing fire protection and forest practices on private land.

Land use conversion to non-forest use involves regulations administered by other state and local governments, which may apply to the future use or development of this site.

Call the Oregon Utility Notification Center at 811 at least 2 business days before starting timber harvesting, road construction, or any other activities involving excavation that may affect an underground utility line. The Center will coordinate with the appropriate utility companies to locate underground utility lines that may be affected by your activities.




