Comment from: Robin Biesecker 1/14/2015

A northern spotted owl (NSO) site was identified within 700 feet of the proposed operation. The temporal restriction period for NSO's is between March 1 and September 30. No operating during the temporal restricted period is permitted without prior approval.

Compliance with Forest Practices Act rules for spotted owls is not in lieu of compliance with any federal requirements related to the federal Endangered Species Act. Federal law prohibits a person from taking northern spotted owls. Taking under the federal law may include significant alteration of owl habitat on any class of land ownership. ODF encourages landowners to consult with the USFWS with regards to compliance with the federal ESA.

Comment from: Robin Biesecker 1/14/2015

ODF has determined that the operation as notified is not likely to pose a conflict for the owl site, thus there are no requirements under the Forest Practices Act rules for spotted owls (OAR 629-600-0100(1)).

Notice to Landowner(s)

Reforestation may be required by the landowner if timber harvesting is part of the proposed operations.

On-site inspections may be conducted by Oregon Department of Forestry employees to ensure compliance with all laws and rules governing fire protection and forest practices on private land.

Land use conversion to non-forest use involves regulations administered by other state and local governments, which may apply to the future use or development of this site.

Call the Oregon Utility Notification Center at 811 at least 2 business days before starting timber harvesting, road construction, or any other activities involving excavation that may affect an underground utility line. The Center will coordinate with the appropriate utility companies to locate underground utility lines that may be affected by your activities.

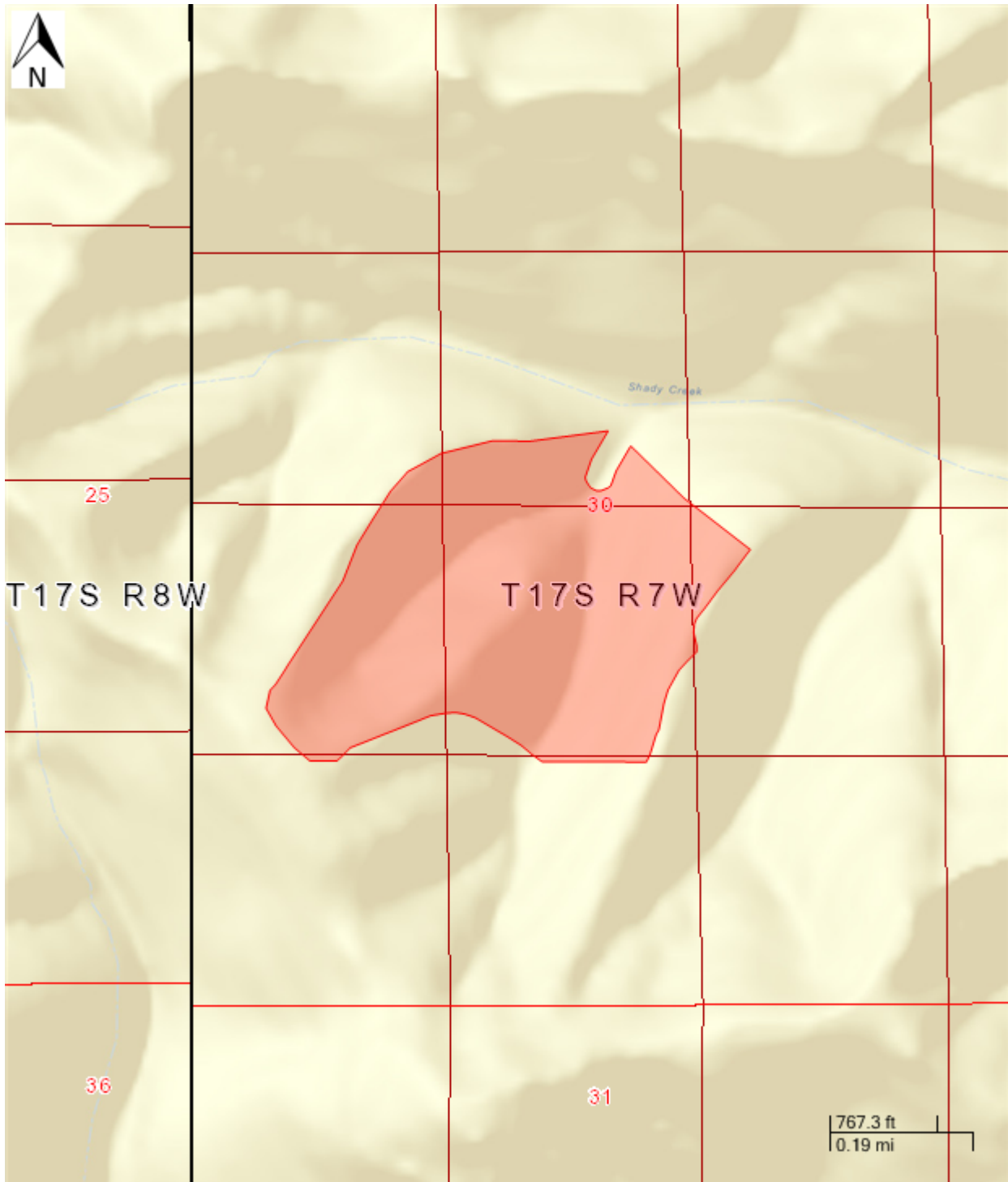

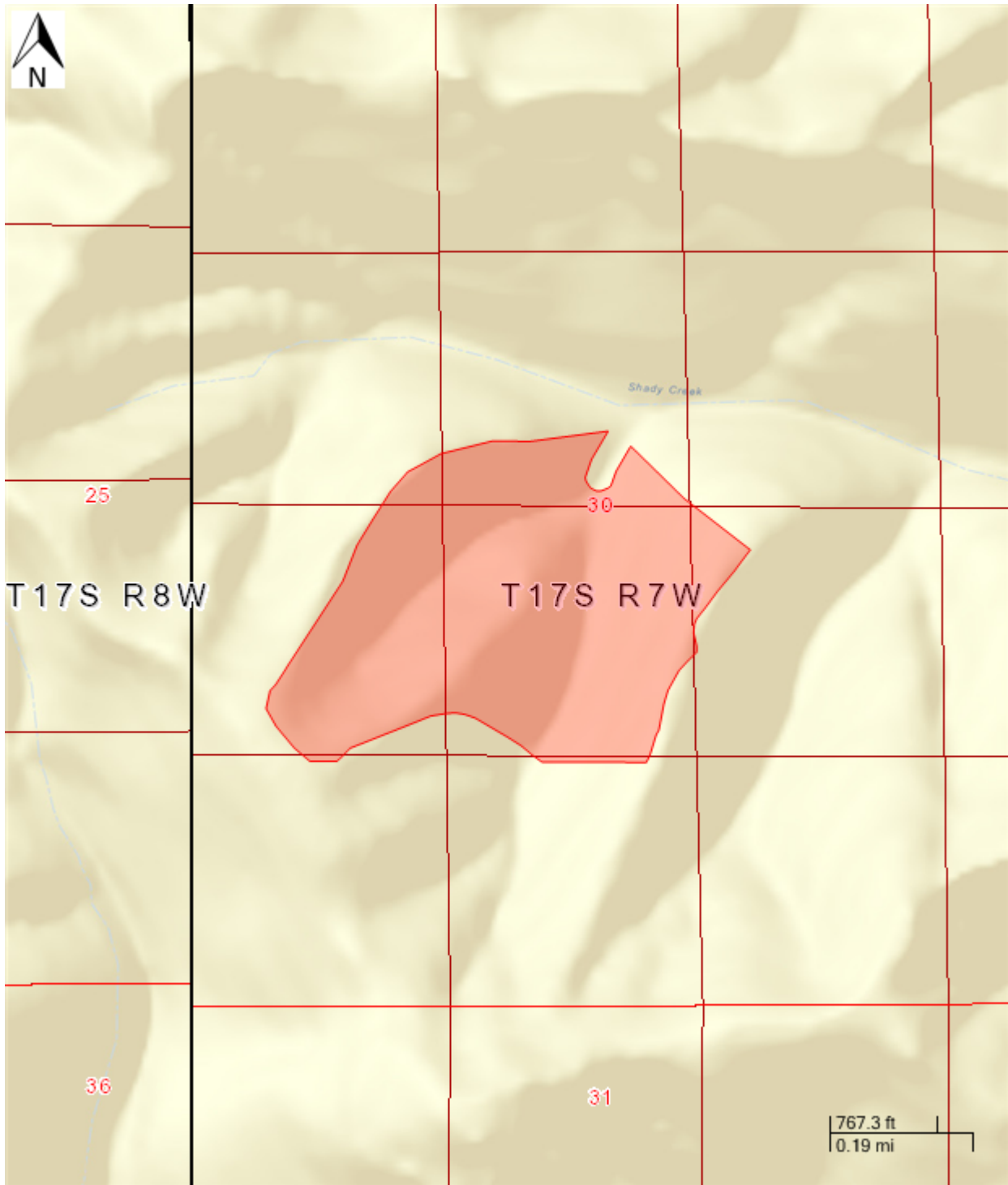
