There is a stream that follows the northwest boundary of the unit located in section 24 of 18S 6W. The stream is labeled as unknown but is labeled as fish in the modeled stream layer. Until a field verification can be made I will treat the stream in question as a Type F. Operations within 100 feet of the Type F stream require a written plan and a 14 to 21 day public comment period prior to operating in the 100 foot area. No written plan has been turned in as of 10/14/2014.

#### Notice to Landowner(s)

Reforestation may be required by the landowner if timber harvesting is part of the proposed operations.

On-site inspections may be conducted by Oregon Department of Forestry employees to ensure compliance with all laws and rules governing fire protection and forest practices on private land.

Land use conversion to non-forest use involves regulations administered by other state and local governments, which may apply to the future use or development of this site.

#### **Notice to Operator(s)**

If you are conducting timber harvesting or road construction within 100 feet of overhead utility lines contact the local utility in accordance with ORS 757.805 - Oregon's Overhead Safety Act and OAR 437-007-0230 - Power Line Safeguards. Identification tags are located on each pole.

Call the Oregon Utility Notification Center at 811 at least 2 business days before starting timber harvesting, road construction, or any other activities involving excavation that may affect an underground utility line. The Center will coordinate with the appropriate utility companies to locate underground utility lines that may be affected by your activities.


